## Eligibility & Team Composition

- 1) A team can consist of either a single member or two members. However, more than two (2) participants in a single team are not allowed.
- 2) Any number of teams may register from a single institution. There is no restriction on the number of eligible teams from one institution.
- 3) The students currently enrolled in either five years or three years LL.B. courses or LL.M. programs from any recognized university are eligible for participation in the competition.
- 4) The competition allows 'cross-institutional' teams. The participants from different institutions may come together to form a team for participation in the contest.
- 5) No changes will be made to the team composition after registration without express permission of the organizing body.

# Rules

## Guidelines for Memorial drafting

The following requirements for memorials must be strictly followed.

Non-conformities will be penalized.

1) All teams must submit a Memorial/ Written Submission for both sides.

2) The Memorials must include all the following specifications.

- A. Cover Page
- B. Table of Contents
- C. List of Abbreviations
- D. Index of Authorities
- E. Statement of Jurisdiction
- F. Statement of Facts
- G. Issues Raised
- H. Summary of Arguments
- I. Arguments Advanced
- J. Prayer
- K. Annexures, if any (not mandatory)

3) The Memorial shall not be of more than forty (40) pages, and the Arguments advance shall not exceed more than twenty-five (25) pages.

4) The Memorial shall be typed on an A4 size page in Font type: Times New Roman, Font size: 12, 1.5-line spacing & 1-inch margin on each side. For footnotes, the font size shall be 10 with 1.0 line spacing.

5) Blue Book (20th Edition) pattern shall be strictly followed. The citation format shall be uniform throughout the Memorial.

6) The Cover Page of the Memorial must follow the following colour scheme, Blue for the Petitioner Cover Page and Red for the Respondent Cover Page.

7) The Team Code allotted to a team must be mentioned on the Cover Page of the Memorial's upper right corner.



8) The Cover Page must consist of the followings:

- A. Team Code
- B. Name of the Court/Forum
- C. Jurisdiction
- D. Cause Title
- E. Party on whose behalf the Memorial is filed.

9) The participants are required to mention only those abbreviations which are used in the Memorial. If an abbreviation is found in the 'List of Abbreviations' but not used in the Memorial, it will attract a negative mark of 1 at a time. The 'Index of Authorities' must reflect the page(s) of Memorial where any authority is cited.

10) The Memorial may consist of an annexure if needed. But must not contain any Photographs/ Sketches/ Exhibits/ Affidavits etc.

11) The submission of the Memorials will be only accepted through Google Form Link, and the Memorials' submission will be only accepted through Google Form Link. No Submission will be accepted after 11:59 Pm on 25th March 2021.

12) Mentioning of identification of any type in the Memorial shall lead to immediate disqualification.

# Submission of Memorial

- 1) Every team which has successfully registered for the competition is required to prepare two memorials:
  - A. Memorial on behalf of the Petitioner
  - B. Memorial on behalf of the Respondent.
- 2) No memorial will be accepted post deadline.
- 3) If the memorial of two teams will be similar to each other than both the teams will be disqualified from the competition.
- 4) After the completion of the Competition, the Organizers reserve the right to use the memorials as they deem appropriate.
